Food Pantry Update

Our Architect firm, the Wight, has completed the conceptual study and cost estimate of a new DuPage Township Food Pantry in Bolingbrook. It would be located between the current township administration building at 241 Canterbury Lane and the Bolingbrook Community Center.

We have presented our formal request to the Village of Bolingbrook for the donation of their portion of the land needed to construct the Food Pantry.

We also sent a formal request to the Will County Executive and the Will County Board for funding of the project under the American Rescue Plan Act (ARPA); my understanding is that the county has not yet set up the application process for this funding, so we may have to submit again once this is set up. CRISIS BUDGETING

Often when folks come in to the General Assistance Office, it's under a time of crisis for them, either job loss, a loss of hours at work, being laid off or even large unexpected expenses. While many seek out financial assistance from various groups or organizations, it's also important to keep the overall picture in mind when it comes to finances. This is where the idea of "crisis budgeting" comes in. Crisis budgeting is done when a household is faced with a financial crisis and needs to readjust their normal household budget to meet their financial obligations. Below are some simple tips to help during times of crisis:

ELIMINATE UNNECESSARY EXPENSES

Get rid of expenses that are not immediately needed such as subscriptions services, cable TV, going out, gym memberships, etc. Whether the crisis is long term or short term, saving money by not spending it on unnecessary things will help.

SPEAK WITH YOUR LENDERS

If you have any type of loans such as students loans, mortgage loans, car loans, etc. speak with the lender to see what options you have if you cannot make payments. Often times lenders will either suspend payments, move payments to end of the loan term or readjust the terms of the loan. Keep in mind that different companies do offer different things so it is vitally important to communicate your situation to your lender and see what options are available.

APPLY FOR PUBLIC BENEFITS

For some folks, there is still a stigma in applying for public benefits such as SNAP (aka food stamps) or medicaid but applying does not mean you have to be on them for long. Also, if you receive benefits, often times you may qualify for other programs, especially if there are children in the home.

APPLY FOR UNEMPLOYMENT

If your crisis is because of a job loss or being laid off, one should apply for unemployment. If approved, it can help with having some income coming in, even if it is not a lot. If you are denied, it can help with applying for other benefits or programs.

APPLY FOR FINANCIAL AID

Even after attempting to move money around and cut out unnecessary expenses, it may still not be enough. Applying for programs like LIHEAP and Emergency Assistance through the township can help alleviate some of the financial burden when it comes to rent or utilities.

ASK FOR HELP

It is natural to feel embarrassed asking for help but that is what different agencies and organizations are here for. So don't feel bad reaching out. That is why the General Assistance Office is here, even if the township is unable to provide specific assistance, it can at least help point you in a direction and refer you to places that might be able to help.

PRESUPUESTO DE CRISIS

Muchas veses, cuando la gente viene a la oficina de ayuda general, en cuando ellos están experimentando una crisis como perdiendo su trabajo, menos horas en el trabajo, despedido por falta de trabajo, o un gasto inesperado. Mientras muchos busca por ayuda financiera de parte de varios grupos u organizaciones, es importante de tomar todo en cuenta sobre sus finanzas. Por eso, uno tiene que hacer un "presupuesto de crisis." Un presupuesto de crisis es cuando un domicilio está experimentando una crisis financiera y tiene que reajustar su presupuesto normal para mantener sus obligaciones financieras. Aquí están algunas ideas sencillas:

ELIMINE GASTOS INNECESARIOS

Deshacerse de gastos que no son inmediatamente necesarios como suscripciones, el cable, saliendo con amigos, membresías de gimnasio, etc. Aunque el crisis puede ser por mucho tiempo o no, puede ahorrar dinero si uno no tiene gastos que no son necessarios.

HABLA CON SUS PRESTEMISTAS

Si tiene cualquier tipo de préstamo como pagos de escuela, hipoteca de la casa o pago de carro, habla con el prestador para ver cuales son sus opciones si no puede hacer su pago mensual. A veses, el prestador puede suspender los pagos, mover los pagos hasta el fin del prestamo o reajustar los términos del préstamo. Tenga en mente que diferentes compañías de préstamo ofrece diferentes opciones, entonces es muy importante de comunicar con sus prestemistas.

SOLICITE POR BENEFICIOS PÚBLICOS

Por ciertas personas, todavía hay un estigma en solicitando por beneficios públicos somo SNAP (estampillas de comida, tarjeta LINK) o ayuda medica pero solicitando no tiene que decir que va estar recibiendo los beneficios por mucho tiempo. Además, si recibe beneficios, puede calificar por otras programas, especialmente si hay niños en el domicillio.

SOLICITE POR EL DESEMPLEO

Si su crisis fue por medio de pérdida de trabajo o al despido de trabajo, debe solicitar por el desempleo. Si se aprueba, puede ayudarle con algunos ingresos, aunque no son muchos. Si le niega, puede ayudar a solicitar otros beneficios o programas.

SOLICITE POR AYUDA FINANCIERA

Incluso después de intentar mover el dinero y cortar los gastos innecesarios, es posible que no sea suficiente. Solicitando por programas como LIHEAP y asistencia de emergencia a través dell township puede ayudar a aliviar parte de la carga financiera cuando se trata de su renta o servicios públicos.

PREGUNTA POR AYUDA

Es natural sentir avergonzado pidiendo por ayuda, pero para eso son las diferentes agencias y organizaciones. Entonces, no se siente mal. Es por eso que la Oficina de Asistencia General está aquí, incluso si el township no puede darle asistencia específica, a lo menos puede ayudarle a orientarlo y referirle a lugares que podrían ayudarle.

Weber & Rt 55 update

DuPage Township has been in contact with the Illinois Department of Transportation (IDOT) to get an update on the status of this project. Currently the construction phase has been halted during the winter months. However, electricians are currently working on the lighting. As soon as weather permitting, the construction will resume.

In June, the intersection will be shut down for two weeks for ALL LEFT-HAND TURNS. The restriction is necessary to finish the traffic signals. That means if you are coming south on Weber, you will not be able to turn left onto northbound I-55. Going north on Weber, you will not be able to turn left to southbound I-55. This also pertains to traffic on I-55. Northbound traffic exiting at Weber will not be able to turn left. Also, southbound traffic on I-55 exiting at Weber will not be able to turn left.

IDOT will be posting detour routes, but they may be very complicated. The best plan would be to avoid the interchange during this phase. Route 53 and I-55 are alternatives. But realize that interchange will be very busy during this phase.

The date for completion of construction work is currently set for late August.

Of course, the shutdown date and completion are subject to weather conditions.
