# Food Pantries Have a Long History of Service to the Township

DuPage Township residents who are in need of supplemental food items can find resources at food pantries in the township. DuPage Township has maintained a food pantry in Romeoville for many years, and several volunteer organizations in the township also maintain food pantries as well. If you are aware of a person or family in need, please let them know that these resources are available.

#### **DuPage Township Food Pantry**

The DuPage Township Food Pantry was established by the Township Board of Trustees to supplement the needs of the Township's residents. In recent years, the Food Pantry has grown from serving approximately 60 families a month to now serving over 1000 families a month.

The Food Pantry is available to DuPage Township families who are experiencing a food crisis. Residents may come to the pantry twice a month and receive a supplement for planning meals for their families. July /August / September 2021

I hope you are having a great summer!

By now you have received your 2020 Tax Bills and paid the first installment! Please check the exemption section and make sure you are getting everything you should be. If you have any questions, feel free to call or stop in our office!

If you have a new exemption to sign up for or if you are just turning 65, then we can help you fill out those exemption forms. Our office is open to the public, Monday – Friday 9:00 am – 4:00 pm

After much research, our office has finalized the 2021 assessment changes and sent them down to the County. If we made a change to your assessment you will receive a letter from the County in August.

If you are getting the Senior Freeze Exemption, any increase in your assessment will not affect you because your assessment is frozen at your base year!

If you ever have a question on your tax bill or your assessment, please stop in our office so we can discuss it! We are here to help you. Sometimes a company will do a mass mailing saying they can "lower your property taxes".... This usually isn't the case, especially if you are getting the senior freeze! Please call our office before you sign up with any firm that says they can lower your property taxes. We have had people say they were charged a lot of money from some of those companies. So, if you get a note about appealing your property taxes or lowering your property taxes, just call our office. We are happy to review your information FREE of charge! You do NOT need to hire an attorney or a tax consultant.

DuPage Township residents can take advantage of local public transportation services to access neighboring communities, regional attractions, and popular local destinations. Pace Suburban Bus has four nearby routes providing convenient connections to downtown Chicago, other Pace service and Metra train lines.

The Pace bus routes in DuPage Township are:

#### **Route 834 - Joliet-Downers Grove**

Provides service from Joliet central business district and Metra Station to Finley & Branding. Serves Lewis University, Good Samaritan Hospital, Romeoville, Lockport, Bolingbrook, Will County Courthouse, Yorktown Shopping Center and Downers Grove. Certain trips connect with Metra-BNSF service in Downers Grove. Posted stop info

#### 850 - North Bolingbrook - East Loop Express

Provides weekday rush hour service between the Pace Canterbury Park-n-Ride in Bolingbrook and portions of the Loop, Streeterville and River North in Chicago. <a href="Posted">Posted</a> stop info

#### 851 - South Bolingbrook - East Loop Express

Provides weekday rush hour service between the Pace Park-n-Ride at White Fence Farm in Romeoville and portions of the Loop, Streeterville and River North in Chicago. **Posted stop info** 

#### Route 755 - Plainfield - IMD - West Loop Express

Provides bi-directional, weekday rush hour service between the Plainfield Park-n-Ride, the Illinois Medical District, and Union Station in the West Loop, with intermediate stops along I-55 at the Pace Park-n-Ride in Bolingbrook, the CTA Pink Line Damen Station and UIC. Route serves Posted Stops Only along the entire route. **Posted stop info** 

Passengers may board and exit the bus at specific locations at Pace bus stop signs, the locations of which are found at the "posted stops info" on our webesite. The one-way fare for the I-55 express services to Chicago is \$4.50 or \$2.50 with a reduced fare card. The regular bus route fare is \$2.00 with a Ventra Card or \$2.25 with cash. DuPage Township Dial-a-Ride service is available for seniors and disabled residents who have an RTA reduced fare card. Eligible residents can travel from their home to locations within the township or to connect with other Pace service. Operating Monday – Friday, 7:00am – 5:00pm, the service costs \$1.00 each way and reservations are taken up to seven day in advance. ### **NEW! Visit www.ChildTaxCredit.gov today**

On Monday, June 21st, the Biden-Harris Administration is encouraging all elected officials and other stakeholders to join us in *Child Tax Credit Awareness Day*—a day of action to get the word out far and wide on the new monthly payments of \$250 to \$300 for each child included in the American Rescue Plan to help families make ends meet. Child Tax Credit Awareness Day will:

- Ensure Americans know about this major tax relief—\$3,000 to \$3,600 per child—for nearly all families.
- Promote the need to **extend these benefits for years and years** as the President has proposed in his American Families Plan.

State, local and tribal officials are encouraged to join the Administration on June 21st in raising awareness, holding events, launching outreach campaigns, and announcing new actions and partnerships so that all children benefit from the historic expansion of the *Child Tax Credit*.

While most families will automatically benefit, state and local leaders have a critical role to play in the effort to ensure all eligible families get the benefits they are eligible for, cutting poverty in their communities. Such leaders could commit to:

- 1. Raising awareness through your office and your official communication channels
  - a. Launch a campaign on the June 21st National Child Tax Credit Day of Action with a press conference or op-ed in your local news outlet
  - b. Add a hyperlink to childtaxcredit.gov on your online landing pages, your e-mail signatures and your newsletters, or other messaging channels
  - c. Lift up the #ChildTaxCredit on Social Media. Some great examples:

     i. Vice President Kamala Harris: @POTUS and I are determined to build a future worthy of every child's aspiration. So we put the children of America at the center of our agenda.
     Today, we released guidance to ensure relief from the American Rescue Plan gets to families with children and childcare providers.
- 2. Leveraging program data and partnerships to target outreach to hard-pressed families
  - a. Identify the families least likely to be receiving Child Tax Credit benefits.
    - i. Where possible and appropriate, use administrative data from state-run programs like SNAP to identify families with children whose incomes may not have been high enough to have had to file taxes in recent years—and provide them information about the simple, non-filer sign-up tool so they don't miss out on benefits.
    - ii. Where possible and appropriate, direct state higher education agencies to target outreach about the Child Tax Credit to students who apply for or receive financial aid as independents with children.
  - b. Help families seeking help.
    - i. Provide families applying for or receiving Temporary Assistance for Needy Families with information about the new monthly Child Tax Credit benefits and—if they haven't filed taxes in recent years or received stimulus payments—assistance signing up.
    - ii. Direct state or county-run SNAP programs to include information on the Child Tax Credit and a link to www.childtaxcredit.gov on their online application portals and in their call center recordings.


### and sign up for monthly payments by July 15, 2021.

- c. Reach families where they live. Mayors could partner with local public housing authorities to post flyers and deliver letters on the expanded Child Tax Credit. Similarly, States could provide owners and property managers of Low Income Housing Tax Credit-aided properties with similar materials.
- 3. Partnering with schools.
  - a. Work with local school leaders to send notices and emails home to parents with information on Child Tax Credit benefits and how to sign-up
  - b. Make Child Tax Credit awareness, and assistance signing-up, part of back-to-school events (e.g. have members of community organizations available to help walk parents through the non-filer sign-up process or collect contact information to follow-up with interested parents at a later date)
  - c. Include information on the Child Tax Credit as part of new school year enrollment or welcome packages and bring in trusted volunteers to run sign-up drives at drop-off and pick-up during the first week of school.
- 4. Engaging communities with trusted messengers.
  - a. Host a meeting with community pediatricians and ask them to provide Child Tax Credit information to the families they see
  - b. Equip local staff directly working with families and children (e.g. Parks and Rec, community ambassadors, COVID Vaccine Ambassadors) with a Child Tax Credit toolkit or partner with entities that receive state and local funding that can reach the most vulnerable families and children, such as family resource centers and domestic violence shelters.
  - c. Engage your community's summer feeding programs, food banks, and local Housing Authorities in an outreach campaign or partner with child care centers in low-income communities to provide information and materials on the child tax credit to families.
- 5. Using caseworkers to reach vulnerable families.
  - a. State and local leaders could add Child Tax Credit-related messages to the scripts or checklists that public workers use when they sign up or check-in with families in their programs. For example, in state or county administered child welfare systems, governors and county officials could:
    - i. Provide materials and talking points on the Child Tax Credit and the non-filer portal for caseworkers to use during their initial and regular check-ins with the parents who are in contact with these systems.
    - ii. Direct their child welfare agency leaders to incorporate information on the Child Tax Credit into their caseworkers' trainings and into existing caseworker tools, such as checklists and lists of resources caseworkers rely on when determining on how to meet the needs of the families they serve.
  - b. Similar approaches could be taken within WIC programs, reaching low-income families with young children during quarterly nutrition education meetings.
