Food Insecurity

One of the major responsibilities of our Township government is the operation of the "DuPage Township Food Pantry." The Township started the food pantry in early 1999. That means the Township has been operating the food pantry for over 22 years. It started out in the conference room at the Township Administration Building. It is currently located at the 719 Parkwood Ave in Romeoville. This location is the old Township Highway Dept. garage. The Food Pantry currently is serving over 1000 families each month who find themselves in need of help.

Upon taking office in May, I commissioned a survey to find out who is using the Food Pantry. The results were that over 70% of the clients were from Bolingbrook, 20% were from Romeoville and 10% were from outside the two villages.

One problem users had was transportation to the Food Pantry, another was having it open only during weekdays when many were working or having only one car that was needed to get to work. The location is situated in an industrial park with low street visibility and a large amount of semi-truck traffic that creates hazardous situation for our customers who are using the pantry.

We solved the weekday problem by opening on Saturday from 9:00AM to 11:00AM As far as the other problems, we are looking to open a Food Pantry in Bolingbrook. This is the concept of bringing the services to the people rather than making the people come to the services.

To accomplish this, we are looking at two possible options.

Option One

Build a new food pantry on Canterbury Lane between the current township offices and the Bolingbrook Community Center which would be highly visible and accessible. We had an architectural firm work up preliminary plans. One problem is the township owns only half the land needed. The other half is owned by the Village of Bolingbrook. We would need them to donate their half to the project. We have discussed with the Village about the land needed but they have not decided whether to donate the land or even allow us to build a food pantry.

A second problem is funding to construct the food pantry. We have talked to the County Executive and also the County Board about getting some of the Federal funds for COVID relief for constructing the Food Pantry. Under the federal guidelines, Food Pantries are one of the projects allowed for funding. The county has been awarded \$137 million in Federal funds. We have had no feedback or response from the County Executive or County Board.

Option Two

The shopping Center located at the junction of Rt. 53 and I-55 (behind the old Family Square Restaurant, currently named the "Tasty Biscuit") is starting to rent out space. We have contacted the rental agent for the property but are not sure if there is any adequate space for a food pantry. Seems the spaces are way too small or way too big. We are looking at other properties, but the best option seems to be building one next to the township offices.

We are hoping that the Village and County will cooperate with us to help feed the needy in our Township.

Food insecurity or more candidly, hunger is not a temporary problem. It has been around for decades and decades and will be around for decades to come.

Providing food to the needy is a responsibility given to the Township.

We are adamant that we will fulfill our responsibility

FREQUENTLY ASKED QUESTIONS (FAQs): COVID-19 VACCINATION

Funding is provided in whole by the IL Dept. of Public Health

Q: If I already had COVID-19, do I still need the vaccine?

A: <u>YES</u>; natural immunity for COVID-19 lasts only a few months and is largely only for the variant that you were infected with. Natural immunity WILL NOT protect you long term and WILL NOT fully protect you against other variants of COVID-19.

Q: What are the side effects of the vaccine?

A: For most people, the side effects from the vaccines are mild and can last up to 36-48 hours, including fever, muscle aches, and headache.

Severe reactions are rare, but you will be observed for 15-20 mins after each dose to make sure you feel okay. If you have had reactions to other vaccines, consult your doctor before you take the COVID-19 vaccine.

Q: Is there a microchip or tracking device in the vaccine?

A: NO; all 3 vaccines WILL NOT inject a microchip or tracking device into your body. The vaccines do not contain either.

Q: Should I get vaccinated if I am pregnant or want to get pregnant in the future?

A: YES; IT WILL NOT be of harm to you or your baby if you are pregnant - in fact, health providers and scientists are strongly recommending that pregnant women get vaccinated to prevent the possibility of severe infection and long-lasting effects for pregnant mothers and their unborn babies. The vaccine is also safe for those who are trying to get pregnant now or later. The vaccine DOES NOT cause infertility or fertility issues.

Q: Can I get COVID-19 from the vaccine?

A: NO; all 3 vaccines CANNOT infect you with COVID-19. The vaccines DO NOT contain the live virus. They simply teach your cells how to create antibodies against COVID-19 to fight off infection if you come in contact with the virus.

Q: Will the vaccine change my DNA?

A: NO; the vaccine WILL NOT alter or change your DNA in any way. The vaccine is only comprised of the genetic material for the surface protein, not the entire virus. It will not change any DNA in the nucleus of your cells.

Q: How were the vaccines developed so fast? Can I trust them?

A: The technology used in the vaccines were not developed as fast as you think. The Pfizer and Moderna vaccines use mRNA technology, which has existed and has been researched for nearly 2 decades. This technology has been studied since the SARS and MERS epidemics in the early 2000s. The Janssen (J&J) vaccine uses a viral vector (not live virus), which many other vaccines use and this method has been studied for decades. COVID-19 vaccines were able to be developed quickly to address the global crisis due to decades of research on how to use the technologies safely and efficiently.





PREGUNTAS FRECUENTES: VACUNACIÓN CONTRA LA COVID-19

El Departamento de Salud Pública de IL suministra toda la financiación.

P: Si ya tuve COVID-19, ¿sigo necesitando la vacuna?

R: <u>SÍ</u>. La inmunidad natural contra la COVID-19 dura tan solo unos pocos meses y es, en gran medida, solo contra la variante con la cual se ha infectado. La inmunidad natural NO lo protegerá a largo plazo y NO lo protegerá totalmente contra otras variantes de la COVID-19.

P: ¿Cuáles son los efectos secundarios de la vacuna?

R: Para la mayoría de las personas, los efectos secundarios de las vacunas son leves y pueden durar entre 36 y 48 horas, incluso fiebre, dolor muscular y dolor de cabeza.

Las reacciones graves son poco frecuentes, pero lo observarán entre 15 y 20 minutos después de cada dosis para asegurarse de que se sienta bien. Si ha tenido reacciones a otras vacunas, consulte a su médico antes de recibir la vacuna contra la COVID-19.

P: ¿La vacuna tiene un microchip o dispositivo de rastreo?

R: <u>NO</u>. Las 3 vacunas NO le inyectarán un microchip ni un dispositivo de rastreo en el cuerpo. Las vacunas no contienen ninguno de estos.

P: ¿Debo vacunarme si estoy embarazada o si deseo quedar embarazada en el futuro?

R: <u>SÍ</u>. NO resultará perjudicial para usted ni para su pebé, en caso de que estuviera embarazada. En realidad, os médicos y los científicos recomiendan fervientemente

la vacunación de las mujeres embarazadas para prevenir la posibilidad de que sufran infecciones graves y efectos duraderos para mujeres embarazadas y sus bebés no nacidos. La vacuna también es segura para quienes buscan un embarazo ahora o planean hacerlo en el futuro. La vacuna NO causa infertilidad ni problemas de fertilidad.

P: ¿Puedo contraer COVID-19 a causa de la vacuna?

R: NO. Las 3 vacunas NO PUEDEN infectarlo con COVID-19. Las vacunas NO contienen el virus vivo. Simplemente les enseñan a sus células cómo crear anticuerpos contra la COVID-19 para combatir la infección si entra en contacto con el virus.

P: ¿La vacuna modificará mi ADN?

R: NO. La vacuna NO alterará ni modificará el ADN de ninguna manera. La vacuna solo contiene el material genético de la proteína de superficie, no el virus completo. No modificará el ADN del núcleo de las células.

P: ¿Cómo es que las vacunas se desarrollaron tan rápido? UPuedo confiar en ellas?

R: La tecnología utilizada en las vacunas no se desarrolló tan rápido como cree. Las vacunas de Pfizer y Moderna utilizan tecnología de ARNm que ha existido y se ha investigado durante casi 2 décadas. Esta tecnología se ha estudiado desde las epidemias del SARS y MERS a principios de la década del 2000. La vacuna de Janssen (J&J) utiliza un vector viral (no el virus vivo), que muchas otras vacunas usan, y este método se ha estudiado durante décadas. Las vacunas contra la COVID-19 se pudieron desarrollar rápido para abordar la crisis mundial debido a décadas de investigación sobre cómo usar las tecnologías de manera segura y eficaz.



GENERAL ASSISTANCE OFFICE NEWS

SALVATION ARMY PROGRAMS

In addition to General Assistance and Emergency Assistance, the General Assistance Office at DuPage Township also serves as an extension office of the Salvation Army. These programs can be used in conjunction with Emergency Assistance or it can be for those who do not qualify for Emergency Assistance or programs such as LIHEAP. If you are in need of assistance, contact the General Assistance Office to see what program you may qualify for. Below is a list of some of the programs that are offered.

Salvation Army Extension

The Salvation Army Extension is the way that they are able to help as many people as possible in the area. While there is no Salvation Army Center in the immediate area, the Salvation Army is able to have a presence through its partnership with local agencies and organizations. The Salvation Army Extension helps those in need with delinquent rent or utility assistance. Assistance can only be given once in a 12 month period.



PROGRAMAS DEL EJÉRCITO DE SALVACIÓN

Además de asistencia general y asistencia de emergencia, la Oficina de Asistencia General en el DuPage Township sirve como una oficina de extensión del Ejército de Salvación. Extensión del Ejército de Salvación

La extensión del Ejército de Salvación es la manera en que ellos pueden ayudar a la gente en el área. Aunque no hay un centro del Ejército de Salvación en el área inmediata, el Ejército de Salvación tiene una presencia por medio de su asociación con agencias y organizaciones locales. El Ejército de Salvación ayuda a la gente que son atrasada con la renta o utilidades. Uno puede recibir ayuda solamente una vez al año.

Nicor Sharing

Nicor Sharing is a one time grant to those who meet the income qualifications (201%-300% of the Federal poverty level) and have experienced a financial crisis such as a drop in income or unexpected expense. The benefit can help with past due balances. Account must be active or grant amount is enough to reinstate service if account is inactive. Veterans who have already applied for LIHEAP can also apply for this program.



El Programa de Compartir de Nicor

El Programa de Compartir de Nicor es un beneficio único por aquellas personas que cumplen con las calificaciones (201%-300% del nivel federal de pobreza) y que ha experimentado una crisis financiera como una reducción de ingresos o un gasto inesperado.

El beneficio puede ayudar con balancias atrasadas. La cuenta tiene que ser activo o el beneficio tiene que ser suficiente para restablecer el servicio si la cuenta no es activo. Veteranos de las fuerzas armadas que han aplicado por LIHEAP puede aplicar por este programa.

Help To Others (H2O)

H2O Help to Others is a customer assistance program created by Illinois American Water and Illinois' Salvation Army agencies. The program helps provide supplemental funding to Illinois American Water residential customers who would otherwise have trouble paying their bills. H2O Help to Others is supported by contributions from Illinois American Water and contributions from customers. Residents can apply for a one time grant that can only be utilized in a 12 month period.

DuPage Township Announces Community Solar Program for Residents and Businesses

DuPage Township is pleased to announce a unique partnership with Solstice Community Solar to bring affordable, clean energy savings to DuPage residents, town buildings, and small businesses.

As an alternative to installing rooftop solar, Solstice enables community members to pay a monthly subscription to a share of a nearby shared solar farm, support clean energy on the grid, and save money on their monthly electric bills--with no upfront costs or changes to their property. With their subscription, customers receive solar credits as a deduction to their electric bills each month, and pay for these credits at a 20% supply side discount through the Illinois Power Authority's Illinois Shines Program.

"DuPage Township is proud to have signed up its own municipal meters for community solar with Solstice, which will provide us significant savings on our electric costs each month and help us lower our carbon footprint," said DuPage Township Supervisor Gary Marschke. "We can't wait for our residents to follow suit in taking advantage of this great opportunity to access the benefits of local clean power."

Community solar is available to most households and small businesses with ComEd as their utility. Subscribers keep their utility company and see no changes to the way their electricity is supplied or delivered.

"What makes community solar so great is that practically our entire Township will benefit from this program if they choose to enroll," said Township Administrator Jackie Traynere. "Since you pay for solar credits at a discount, you'll save on your bills--without paying added fees to join or paying any ongoing subscription costs. This is truly a win for our community."

"At Solstice, we believe clean energy savings should belong to everyone, not just those who have the right roof and enough savings to be able to buy their own solar panels," said Solstice Partnerships Coordinator Alex Goldfarb. "We're thrilled to be able to bring this opportunity to DuPage residents, many of whom can now participate in the green economy for the first time."
