A RESOLUTION

SETTING COMPENSATION FOR ELECTED TOWNSHIP OFFICIALS FOR THE FOUR-YEAR TERMS COMMENCING IN THE YEAR 2021 AND 2022

WHEREAS, DuPage Township (the "Township") is an Illinois unit of local government organized and operating pursuant to the Illinois Township Code, 60 ILCS 1/1 et seq. (the "Code"); and

WHEREAS, pursuant to Section 2 of the Local Government Compensation Act, 50 ILCS 145/1, et seq., and pursuant to Section 65-20 of the Illinois Township Code, the Township Board of DuPage Township is required to fix the compensation for the DuPage Township Elected Officers at least 180 days before the beginning of the terms of office, which commence on May 17, 2021; and

WHEREAS, according to Section 2-70 of the Illinois Property Tax Code, 35 ILCS 200/1-3, et seq., and Section 65-20 of the Illinois Township Code, the compensation the Township Assessor and Township Collector shall be set by the Township Board at the same time the Board sets the compensation of its Township Supervisor; and

WHEREAS, the said Township Board has diligently and carefully reviewed the functions and responsibilities of the elected officials' offices to be filled at the Consolidated Election to be held on April 6, 2021, and has determined levels of compensation required to ensure the continued effective and efficient administration of Township government by devoted and professional officials.

NOW, THEREFORE BE IT AND IT IS HEREBY RESOLVED by the Township Board of Trustees of DuPage Township that the compensation for the DuPage Township Elected Officers for the four-year terms, commencing on May 17, 2021, (with the Assessor's term commencing on January 1, 2022) shall be as follows:

SECTION 1: The annual salaries for the Township Officials, payable in equal installments according to the Township's applicable payroll policy, shall be as follows:

- **SECTION 2:** In addition to the Compensation outlined in Section 1 above, the Assessor shall be eligible to receive insurance benefits currently in effect for any full-time employees of the Township and shall additionally receive payment for any costs assessed to full-time employees as part of said insurance benefits.
- **SECTION 3:** The Supervisor and Assessor may participate in the Illinois Municipal Retirement Fund (IMRF) if they meet the eligibility requirements.
- **SECTION 4:** The Supervisor and Assessor are eligible for basic long-term care insurance coverage at no cost. They may add coverage for family members and/or enhance the basic coverage at their own expense.
- **SECTION 5:** The Supervisor, Clerk, and the four Township Trustees begin their new term of office May 17, 2021, and this Compensation Resolution for these offices is effective as of May 17, 2021.
- **SECTION 6:** The Assessor and Township Collectors begin their new term of office on January 1, 2022, and this Compensation Resolution for this office is effective as of January 1, 2022.
- **SECTION 7**: The above-stated salaries and benefits shall be payable in equal installments and shall be subject to regular, applicable payroll deductions all in accordance with the policies and procedures adopted for employees of said Township.
