CALL TO ORDER: Meeting was called to order at 7:00 PM

PLEDGE OF ALLEGIANCE: Pledge of Allegiance was recited by all and lead by Clerk Parker.

ROLL CALL FOR QUORUM: Trustees Braxton, Ransom, Savage, Townsend, and Supervisor Marschke were present via roll call vote, so a quorum was determined.

APPROVAL OF AGENDA: A motion was made by Trustee Braxton and seconded by Trustee Ransom to approve the agenda as presented. Upon roll call vote agenda approval passed.

APPROVAL OF REGULAR MARCH 21, 2023 BOARD MEETING MINUTES: A motion was made by Trustee Braxton and seconded by Trustee Townsend to approve the regular meeting minutes from March 21, 2023. Upon roll call vote, motion carried to approve the March 21, 2023 meeting minutes.

APPROVAL OF REGULAR APRIL 6, 2023 BUDGET HEARING MINUTES: A motion was made by Trustee Ransom and seconded by Trustee Braxton to approve the budget hearing minutes from April 6, 2023. Upon roll call vote, motion carried to approve the April 6, 2023 hearing minutes.

APPROVAL OF APRIL 6, 2023 SPECIAL BOARD MEETING MINUTES: A motion was made by Trustee Savage and seconded by Trustee Braxton to approve the special meeting minutes from April 6, 2023. Upon roll call vote, motion carried to approve the April 6, 2023 special meeting minutes.

SUPERVISOR'S REPORT: Supervisor read an email sent by Mayor Basta and a letter from Representative Avelar. Both are attached.

ACTION ITEMS:

1. **DISCUSSION AND APPROVAL OF EMERGENCY REPAIRS TO BOTH FOOD PANTY VEHICLES:** After some discussion and questions asked and answered, a motion was made by Trustee Savage and seconded by Trustee Braxton to approve the repair to both vehicles in the amount of \$4,874.83. Upon roll call vote, the motion carried.
2. **DISCUSSION AND APPROVAL FOR PURCHASE OF A REPLACEMENT GARBAGE HOPPER:** After some discussion and questions asked and answered, a motion was made by Trustee Ransom and seconded by Trustee Townsend to approve the replacement of the garbage hopper (\$1,942.81 plus delivery fee of \$285.00). Upon roll call vote, the motion carried.
3. **DISCUSSION AND POSSIBLE APPROVAL OF ORDINANCE 23-07 RULES REGARDING PUBLIC PARTICIPATION AT TOWNSHIP MEETINGS:** After some discussion, a motion was made by Trustee Ransom and seconded by Trustee Townsend to table this item until the May Board Meeting. Upon roll call vote, motion carried.
4. **DISCUSSION AND POSSIBLE APPROVAL TO UPDATED ARCHITECT CONTRACT:** After some discussion and questions asked and answered. A motion was made by Trustee Braxton and seconded by Trustee Savage approve this change. Upon roll call vote, motion carried.
5. **DISCUSSION AND APPROVAL TOOLS FOR SCHOOL ITEMS:** After some discussion, a motion was made to approve up to \$20,196.99 to purchase items for this project. Upon roll call vote, motion carried.
6. **DISCUSSION AND POSSIBLE APPROVAL TO INCREASE COMPENSATION FOR ONE BANQUET EMPLOYEE:** After some discussion and questions asked and answered, a motion was made by Trustee Ransom and seconded by Trustee Townsend to approve the

additional pay when needed at an event. Upon roll call vote indicated motion carried.

7. **APPROVAL OF RES 23-17 REPORTING THE DETERMINATION OF THE REVIEW OF CLOSED SESSION MINUTES:** After some discussion, a motion was made by Trustee Ransom and seconded by Trustee Townsend to approve this resolution Upon roll call vote, motion carried.

General Assistance Report

Tuesday, April 18th, 2023

- For the month of March, the General Assistance Office had 13 applications for Emergency Assistance. 4 households were approved for assistance. Two households were assisted with their rent and two others for their IL American Water bill. One household from Wheatland Township had applied for assistance and was approved. The Wheatland Township resident was assisted with their City of Aurora water bill. One household who applied in March still has a pending application. Eight households had their applications denied. The reasons for the denied applications include: not facing a "life-threatening" circumstance, meaning they did not have an eviction order or 5-day notice or shut-off order for their utility, another reason for denials were because the amount the township would pay would not be enough to alleviate the "life-threatening" circumstance, for example, having a past due rent of thousands and thousands of dollars, one applicant withdrew their application, one applicant was from outside the township (and county) and another applicant was non-cooperative in the application process.
- In regards to some of the additional programming through the GAO, one household that was referred by Valley View School District was given two Goodwill Vouchers. Seven households were assisted through the H2O program for help with their IL American Water bill and one household was assisted through the Salvation Army Service Extension program for their rent.
- In March, 65 households came to the office and applied for LIHEAP. Some of those numbers are starting to go up, probably because we're trying to get the word out about the program year ending at the end of May.
- Recently, I have been keeping track of referrals and resources the office has been giving out. For the month of March, approximately 114 referrals were given to residents, either in person or over the phone. The break down is: 41 for LIHEAP, 37 for other resources in the community (not necessarily fitting into one or more categories), 11 referrals for the food pantry, 9 referrals for out of township residents, 8 referrals for the Will County Center for Community Concerns for any non-LIHEAP programs, 4 legal referrals, 3 financial resources were given out and one referral for IDHS.
- Lisa Mendez from Hines VA has been having success with coming to the township to help veterans enroll for benefits. While she's been averaging about four to five veterans each time she comes out, Lisa has stated that compared to other places she does outreach, the township has been where she sees the most veterans. We've been doing a sort of "trial run" at the beginning of the year and since it's been fairly successful, Supervisor Marschke has agreed to have the Hines VA outreach come out regularly on the 2nd Thursday of the month moving forward.
- I recently had a meeting for the advisory committee for the Human Services program at JJC. The program director, Heidi Munsey, mentioned that some Human Services students wanted to get some volunteer experience in social services over the summer and so I forwarded along to Heidi the flier looking for counselors for the Summer Bridge program.
- Lastly, I will be attending Valley View School District's Quarterly Partner meeting tomorrow and I'll also be attending the IL Township Association of General Assistance Caseworkers, educational conference that will be going on later this week in Peoria.
