Itemized Description of Work To Be Completed

Upon inspection of the roof, we are hereby pleased to submit an estimate as follows;

Kolony Restoration agrees to furnish all labor, materials, services, installation, supplies, insurance, permits, equipment, tools, and other facilities required for the prompt and efficient execution of the work described herein, in a professional and workmanlike manner. All workmanship and materials used, shall comply with or exceed all local and state building codes. General Liability and Worker Compensation Insurance shall be provided upon request.

1. Remove existing layer of wood shake roofing and underlayment down to original wood decking. Remove all existing decking. All debris will be placed directly into waste container provided by Kolony Restoration. We utilize our own trailer for all debris removal. (No big dumpster necessary). Premises will be thoroughly cleaned upon completion. Only enough roofing will be removed that can be replaced the same day.
2. Provide and install new 1/2" 4-ply CDX plywood.
3. Provide and install upgraded synthetic roofing underlayment on entire roof.
4. Provide and install asphalt shingle starter strip along all eaves.
5. Provide and install **IKO, Dynasty** architectural style shingles. Each shingle to be fastened with no less than 5, 1-1/4" inch galvanized roofing nails, per manufacturer specifications.
6. Provide and install new Hip & Ridge cap shingles.
7. Provide and install new aluminum drip edge on all eaves.

**All payments are due within 5 calendar days of the completion of work. Progressive billing payments to be made as project line items are completed. A 5% interest charge will be applied to all outstanding balances beyond 5 calendar days and a letter of intent to lien will be sent to all parties involved for any outstanding balances over 21 days past due.

TERMS & CONDITIONS:

Payment Terms. Customer shall pay 30 % of the Total Cost (defined above) as a down payment, 30% at 50% of project completion, and the remainder of the Total Cost, on the date of completion of the defined herein Services. Payment shall be made to Naperville Roofing and Construction.

Acceptable payment methods include: cash, checks, Visa and Master Cards (3% credit card fee apply).

Late payments, are subject to 5% monthly late fee.
Insufficient checks are subject to one time \$50 administrative fee.

Customer shall pay all costs of collection, including without limitation, court costs and reasonable attorney fees.

Work Days

The Roofing work will be performed Monday through Saturday, statutory holidays excluded, unless the parties mutually agree otherwise, provided that the services will be performed only if weather conditions are favorable, in order to ensure an acceptable finished product.

Work Site

Customer authorizes Naperville Roofing and Construction to commence/complete the usual and customary excavation and grading on the work site as may be required in the judgment of Naperville Roofing and Construction to complete the roofing work. Unless called for in the drawings or specifications, no landscaping, finish grading, filling or excavation is to be performed at the work site by Naperville Roofing and Construction.

Permits

Naperville Roofing and Construction shall apply for and obtain such permits and regulatory approvals as may be required by the local municipal /county government, the cost of permits is included in pricing.

Insurance

Naperville Roofing and Construction shall maintain insurance in accordance with the minimum requirements of the state throughout the duration of the services. Proof of said insurance shall be made available to Customer upon request.

Change Orders

Customer may make changes to the scope of the work from time to time during the term of this contract. However, any such change or modification shall only be made by written "Change Order" signed by both parties. Such change orders shall become part of this contract. Customer agrees to pay any increase in the cost of the roofing work as a result of a change order. In the event the cost of a change order is not known at the time a change order is executed, Naperville Roofing and Construction shall estimate the cost thereof and customer shall pay the actual cost whether or not it is in excess of the estimated cost.

Access

Customer will allow free access to work areas for workers/vehicles and will allow areas for the storage of materials and debris. Driveways will be kept clear for the movement of vehicles during work hours. Naperville Roofing and Construction will make reasonable efforts to protect driveways, lawns, shrubs, and other vegetation.

Warranty

Naperville Roofing and Construction shall provide its services and meet its obligations under this contract in a timely and workmanlike manner, using knowledge and recommendations for performing the services which meet generally acceptable standards in Naperville Roofing and Construction's community and region, and will provide a standard of care equal to, or superior to, care used by contractor's similar to Naperville Roofing and Construction on similar projects. Naperville Roofing and Construction's warranty shall be limited to defects in workmanship within the scope of work performed by Naperville Roofing and Construction and which arise and become known within 5 years from the contract date. Naperville Roofing and Construction agrees to repair any roofing leaks under normally anticipated weather conditions, wherein ice damming is not a normally anticipated condition. Damage done to the roof system through no fault of Naperville Roofing and Construction are not warranted by Naperville Roofing and Construction. All said defects arising after 5 year and defects in material are not warranted by Naperville Roofing and Construction. Naperville Roofing and Construction hereby assigns to customer all warranties on materials as provided by the manufacturer of such materials. Naperville Roofing and Construction is not responsible for customer's failure to complete warranty documents, or complete any/all instructions, resulting in cancellation of said manufactures warranty.

Default

The occurrence of any of the following shall constitute a material default under this Contract: (a) The failure to make a required payment when due; (b) The insolvency or bankruptcy of either party; (c) The subjecting of any of either party's property to any levy, seizure, general assignment for the benefit of creditors, application or sale for or by any creditor or government agency. (d) The failure to make available or deliver the services in the time and manner provided for in this contract.

Termination

Either party may terminate this contract at any time, without notice, provided that each party is compensated for work completed and materials utilized in providing Services. Naperville Roofing and Construction shall have the right to retain the deposit for efforts related to quoting and planning of services.

Completion of Service

Upon the completion of services, Naperville Roofing and Construction will restore customer's property to the condition prior to the service.

Dispute Resolutions

Any/all disputes arising out of or relating to this contract shall be resolved by binding arbitration in accordance with the then-current Commercial Arbitration Rules of the American Arbitration Association. The arbitrator(s) shall not have the authority to modify any provision of this Contract or to award punitive damages. Arbitrator's decision shall be final and binding on the parties, and judgment may be entered in conformity with the decision in any court having jurisdiction. The agreement to arbitration shall be specifically enforceable under the prevailing arbitration law. WHEREAS, the County of Will (COUNTY) has received grant funds from the United States Department of the Treasury under the State and Local Fiscal Recovery Funds program; and

WHEREAS, the COUNTY is committed to utilizing the grant funds provided to it under the State and Local Fiscal Recovery Fund (GRANT FUNDS) program to support target populations, industries, sectors, and specific businesses or agencies affected by the COVID-19 pandemic; and

WHEREAS, the COUNTY desires to use the GRANT FUNDS to reimburse the Township of DuPage (TOWNSHIP) for certain expenses incurred because of the COVID-19 pandemic; and

Project “R”

**An initiative of the Academy for Restorative
Education and Community Success
(ARECS)**

OVERVIEW

Project “R”, named to echo the relationship- and reflection-focused values of restorative practices, is a foundational service offered by the Academy for Restorative Education and Community Success (ARECS), a part of the Lewis University Community Schools Consortium (LUCSC). ARECS activities provide youth with high-quality, accessible opportunities for learning and growth in place of punitive disciplinary actions. As one of these initiatives, Project “R” brings together numerous services and activities to create a comprehensive, integrated support program for high school youth and their families.

FROM THEN TIL NOW

Project “R” aims to honor the impact of the HEART Organization, a hub of services within Will County, which was founded by Ms. Joann Robinson in 1999 and continued by Dr. Leonard Ingram until 2022. The HEART Organization ran the Success Academy, an alternative-to-suspension and court diversion program offered to high school students and young adults and their families free of charge. The Success Academy assisted middle and high school students in Valley View School District (VVSD) and other school districts who had committed an infraction that warranted a 10-day suspension. The intent of the Success Academy was to reduce out-of-school suspension and to support the student in better understanding consequences, rules, and the impact of their actions, leading to character development.

To do this, the Success Academy invited experts in the field of juvenile delinquency and social skills-development to facilitate instructional components of the program. One of the facilitators - Associate Professor Tammy Thurman, a faculty member at Lewis University with a background in law and social work - has continued the work of the Success Academy and the HEART Organization since the retirement of Dr. Ingram. Professor Thurman brings the lessons and wisdom learned via Dr. Ingram’s mentorship to present-day practices to Project “R.” Professor Thurman and Professor Huma Zia (Lewis faculty member in Justice, Law and Public Safety Studies) continue to offer ‘Legal Literacy’ classes for students facing significant disciplinary action within VVSD.

CURRENT HAPPENINGS

During the 2022-2023 academic year, a reimagined pilot of Success Academy, called Project “R,” engaged 25 VVSD students across three separate sessions. End-of-program feedback demonstrated students responded positively to the program, indicating they most favored the content and instructors, and felt less positively about the location of the program (which took place at Brooks Middle School in the STEP campus classrooms). When asked ‘*What did you most like?*’, qualitative survey responses included statements such as: “*I learned about different things that I never knew*” and “*the thinking puzzles*” and “*how interactive it is*”. When asked ‘*What did you like least?*’ or ‘*What would make the program better?*’, qualitative survey responses from

participants included statements such as: “the classroom” or “I think better chairs” or “the shouting out and people coming late”. Additional data is in the table below.

LOOKING TO THE FUTURE

Moving forward, through the new LUCSC-based Academy for Restorative Education and Community Success (ARECS), Project “R” will not only include 3-5 weeks of intensive coursework focused on civic engagement, but also incorporate services and activities meant to build community and support family members. These additional activities will include, for example: community-building peace circles, resource provision, school-focused and school-based check-ins from LUCSC professionals to bring together learning environments, and even offer therapeutic mental health service referrals for students and their family members.

While honoring the work of Ms. Robinson and Dr. Ingram through the HEART Organization for youth and families in Will County, the LUCSC team aims to enhance and expand the offerings of Project “R.” Proposed programming includes:

- Individualized intake sessions with all referred students, leading to stronger relationships and direct connections to the school day
- Eight-week program sessions, with two 3-hour meetings per week
- Participation in ‘community time’ which involves semi-structured individual- and group-self-care activities and a nutritious snack
- Engagement in community-building peace circles
- Family engagement via required parent/family meetings and participation
- Access to mental health services and supports for students and their families from partnering community agencies.
