CALL TO ORDER: Meeting was called to order at 6:04 PM by Clerk Parker.

PLEDGE OF ALLEGIANCE: Pledge of Allegiance was recited by all and lead by Trustee Debi Savage.

ROLL CALL FOR QUORUM: Trustees Braxton, Ransom, Savage, and Townsend, and Supervisor Marschke were present via roll call vote, so a quorum was determined.

Clerk Parker called for a motion to name an acting Chair of this board meeting. A motion was made by Supervisor Marschke and seconded by Trustee Savage to name Trustee Braxton as acting Chair of this meeting. Upon roll call vote, motion carried.

APPROVAL OF AGENDA: A motion was made by Trustee Savage and seconded by Trustee Ransom to approve the agenda as presented. Upon roll call vote agenda approval passed.

APPROVAL OF October 15, 2024 MEETING MINUTES: A motion was made by Trustee Townsend and seconded by Trustee Savage to approve the October 15-2024 Board meeting minutes. Upon roll call vote, motion carried to approve the October 15, 2024 board meeting minutes as presented.

ACTION ITEMS:

DISCUSSION AND APPROVAL OF RESOLUTION 24-18 Elected Official Compensation. – Acting Chair Braxton read the resolution. After much discussion, a motion was made by Trustee Townsend and seconded by Trustee Savage to amend the salaries to: Supervisor - \$40,000; Clerk to remain \$15,000; Trustees to 10,000; Collector to remain \$1,200, and Assessor to remain \$100,000. Upon roll call vote, motion passed with Supervisor Marschke abstaining. A motion was made by Trustee Savage and seconded by Trustee Townsend to approve Resolution 24-18 with new salaries. Upon roll call vote, motion passed with Supervisor Marschke abstaining.

DISCUSSION AND APPROVAL FOR HOLIDAY MEAL PURCHASES AT FOOD PANTRY - After some discussion on the cost of pies, A motion was made by Trustee Ransom to take \$3,915.59 from the contingency fund to add to the holiday meals line and seconded by Trustee Savage. Upon roll call vote, motion passed unanimously.
