DISCUSSION AND POSSIBLE APPROVAL FOR SECURITY CAMERA REPAIR AT THE FOOD PANTRY. After some discussion, Trustee Townsend made a motion to approve the repair of security cameras at the food pantry. Trustee Braxton seconded the motion. Upon roll call vote, motion carried.
