

TAX LEVY ORDINANCE  
DUPAGE TOWNSHIP  
ORDINANCE NO. 25-18

An ordinance levying taxes for all town purposes for DuPage Township, Will County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of DuPage Township, Will County, Illinois, as follows:

SECTION 1: That the sum of TWO MILLION NINE HUNDRED SEVENTY EIGHT THOUSAND, EIGHT HUNDRED FORTY EIGHT (\$2,978,848.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL TOWN FUND,  
GENERAL ASSISTANCE FUND,  
For the year 2026.

SECTION 2: That the total amount levied shall be as follows:
